OTHER ISSUES:

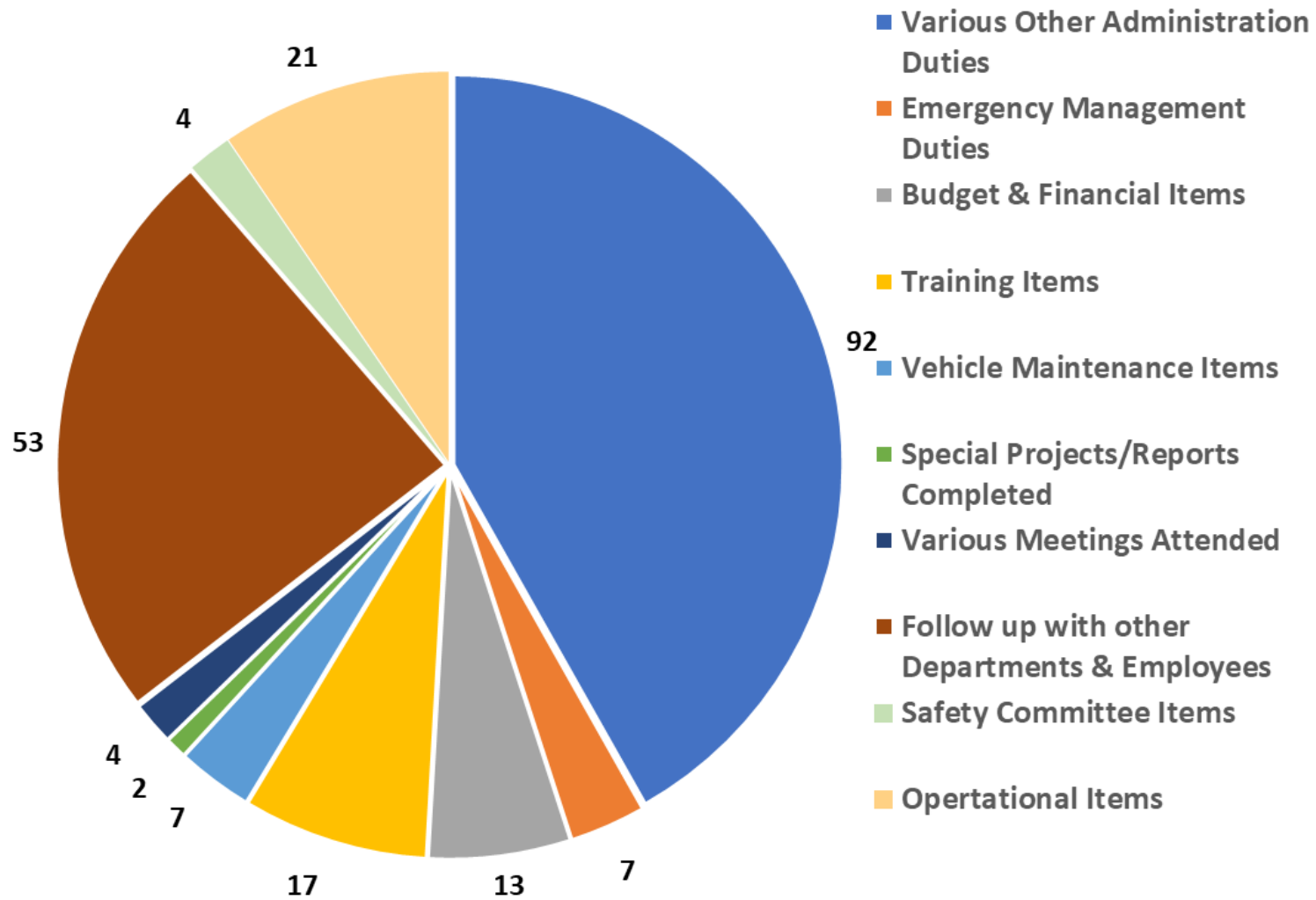

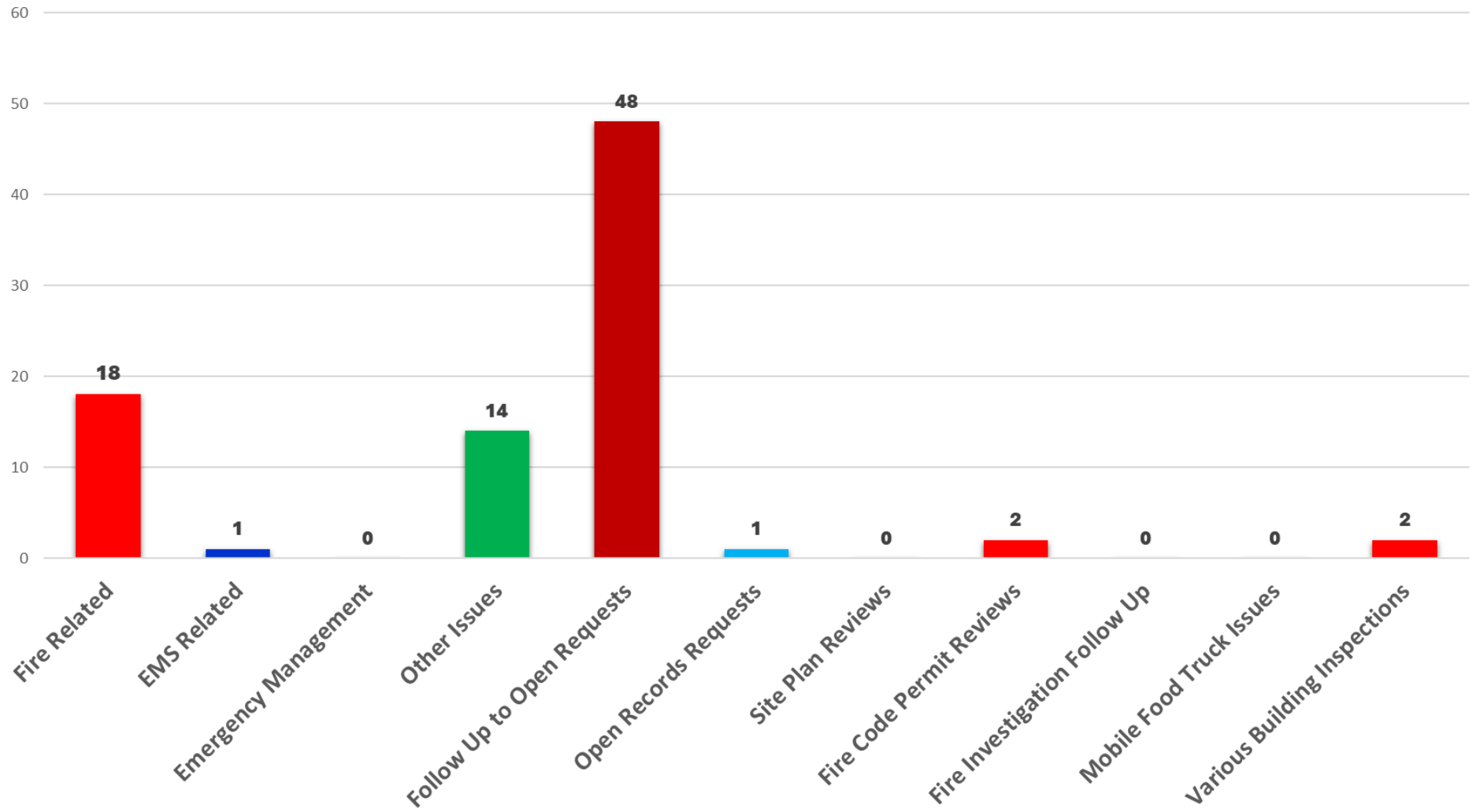
