TRAINING:

On Tuesday, January 2, 2024, Fire Marshal, David M. Camarda, and Deputy Fire Marshal, Michael A. Barnshaw reviewed a 1-hour online training webinar on Electric Vehicles.

On Saturday, January 6, 2024, Fire Marshal, David M. Camarda completed a 6-hour Hazardous Materials Operations Refresher course. This is an annually required refresher for all fire service personnel.

On Saturday, January 6, 2024, Fire Marshal, David M. Camarda completed a 1-hour Stop the Bleed course.

On Thursday, January 25, 2024, Deputy Fire Marshal, Michael A. Barnshaw was conferred his Fire Investigator Technician Certification, from the International Association of Arson Investigators.

OTHER ISSUES:

On Friday, January 5, 2024, Fire Marshal, David M. Camarda, and Deputy Fire Marshal, Michael A. Barnshaw were on hand, along with members of the United States Secret Service agency, to assist with site safety during the visit of President Joseph Biden. The President made a visit to the township and spoke at the Montgomery County Community College's Science Center auditorium. At the end of the event, both Dave & Mike were provided the opportunity to meet the President and First Lady, Jill Biden.

On Wednesday, January 10, 2024, Fire Marshal, David M. Camarda, and Deputy Fire Marshal, Michael A. Barnshaw met with Pennsylvania American Water Company officials at their Norristown Office. The meeting's purpose was to introduce Mike and to review open issues with some fire hydrants.

On Tuesday, January 23, 2024, Fire Marshal, David M. Camarda, and Deputy Fire Marshal, Michael A. Barnshaw met with management staff at the VEVA business campus, on Sentry Parkway West. The meeting was to review voluntary automatic sprinkler retrofitting in four buildings at the site. The good news is that all four buildings are now 100% protected with automatic sprinkler systems.




