WHITPAIN TOWNSHIP FEE SCHEDULE

A RESOLUTION FIXING FEES FOR BUILDING PERMITS, PLUMBING PERMITS, MECHANICAL PERMITS, ZONING HEARING BOARD FEES, ZONING FEES, CONDITIONAL USE HEARING FEES, ZONING ORDINANCE AMENDMENT APPLICATION FEES, REZONING APPLICATION FEES, SUBDIVISION AND LAND DEVELOPMENT PLAN REVIEW AND SUBMISSIONS FEES, SANITARY PERMITS AND CONNECTION FEES, MUNICIPAL PRE-TREATMENT FEES AND MISCELLANEOUS FEES PURSUANT TO PERMIT REQUIREMENTS ESTABLISHED UNDER THE CODES OF THE TOWNSHIP OF WHITPAIN.

WHEREAS, certain Township fees require adjustment to adequately cover Township costs; and

WHEREAS, Chapter 16, Section 16-2 of the Code of the Whitpain Township authorizes revisions or amendments to the Township Fee Schedule in whole or in part by resolution adopted at a regular meeting of the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of Whitpain Township hereby revises the Whitpain Township Fee Schedule as follows to be effective January 1, 2026 and until further amended by resolution of this Board:

Subdivision and Land Development Fees

For Land Development and Subdivision Agreements, a seven (7%) percent charge will be applied to each monthly invoice to cover Township administration charges and costs. This fee will be deducted from Developer's Cash Escrow.

Established Land Value for Open Space Calculation

The established per acre land value for purposes of calculating Open Space Contributions established by §311 of the Subdivision and Land Development Ordinance of Whitpain Township and by Resolution adopted by the Board of Supervisors on April 6, 1979 is Ten Thousand (\$10,000.00 Dollars, per acre, effective as of June 30th, 1979. Thereafter, for purposes of Open Space Valuation, the Ten Thousand (\$10,000.00) Dollar amount shall be adjusted to a sum which shall be equal to the total of the following: (1) \$10,000. per acre, and (2) the product of multiplying \$10,000. by the percentage increase, if any, in the level of the official All City Consumer Price Index published by the Bureau of Labor Statistics of the United States Department of Labor (the CPI) for the month in which such calculations is made over the level of the CPI for June. 1979.

*The Escrow Fee is considered a Professional Review and Inspection Escrow as part of the Subdivision and Land Development application review process. For Land Development applications, it also includes costs associated with Township engineering inspections during the construction process. These funds are collected by the Township and are used to pay fees associated with professional services provided by Township staff and consultants (engineering fees, legal fees, administrative fees, inspection fees, etc.) for the subject application.

The escrow fee is held by the Township and unused fees are returned to the applicant at the request of the applicant after the Township is provided with the recording receipt from the Montgomery County Recorder of Deeds for all plans and required documents (Subdivision) or the construction on the project is completed and accepted by the Township (Land Development). The Township will require the applicant to fully replenish depleted escrow accounts to the original escrow amount when funds attain a funding level of \$3,000.00.


