**PHYSICAL DESCRIPTION:**

**Marabella's Restaurant**

This 3-part building consists of a heavily altered Georgian style core and a modern end and rear addition. The core is 2.5 stories with an end gabled, asphalt shingle roof. The walls consist of un-coursed stone with a masonry flash course under the second floor windows. The flash course, which wraps around the south end of the core, indicates that a pent roof was once attached to the building. The core is 5-bay wide with a center door. There are two flush chimneys at each end of the building, both covered in stucco. At the attic floor, there are two large monitor dormers running almost the entire length of the building on each side of the roof. Fenestration consists of new 6x6 sash windows. The first floor windows are flanked by solid paneled shutters; louvered shutters flank the second floor windows. The door, also not original, is a paneled unit flush with the wall. A decorative wood pediment is located over the door. The core measures 35'x 20'.

A modern, single story addition is located on the north end of the building. The 3-bay wide unit is clad in stucco and has modern Mansard roof covered with wood shingles. There is also a large single story addition attached to the rear of both the core and the addition. It has similar features as the end addition. The overall dimensions of the building, including core, are 50'x 100'.

**Classification:** The building has been altered, but the Township considers it to be a landmark building conveying a sense of history. Class I.
