AN ORDINANCE AMENDING THE WHITPAIN TOWNSHIP CODE OF ORDINANCES
AT CHAPTER 108 "PARK AND PLAYGROUNDS"

IT IS HEREBY ENACTED AND ORDAINED by the Board of Supervisors that the Whitpain Township Code of Ordinances shall be amended as follows:

SECTION 1. **Amendment to Chapter 108 [Parks and Playgrounds], Section 108-4(2) [Rules and Regulations for Specific Activities] as follows, with the stricken text indicating the deleted language and bolded text indicating the new language:**

G. Dogs

1. Dogs must be on a leash and under the owner's control.
2. The leash may not exceed ~~40~~ **6** feet. **No retractable leashes are permitted.**

SECTION 2. **Repeal and Ratification.**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. **Severability.**

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.

SECTION 5. **Effective Date.**

This Ordinance shall become effective 5 days after enactment.
