AN ORDINANCE AMENDING THE TOWNSHIP'S CODE CHAPTER 142 (VEHICLES AND TRAFFIC) ARTICLE IV (STOPPING, STANDING, AND PARKING) SECTION 142-37 (SPECIAL PURPOSE PARKING ZONES) TO REMOVE ONE SPECIAL PURPOSE PARKING ZONE LOCATED ACROSS FROM 337 W. MAPLE AVENUE IN FRONT OF 336 W. MAPLE AVENUE AND RETAIN SPECIAL PURPOSE PARKING IN FRONT OF 338 W. MAPLE AVENUE AND 450 RAILROAD AVENUE

IT IS HEREBY ENACTED AND ORDAINED by the Whitpain Township Board of Supervisors as follows:

SECTION 1. Amendment to Chapter 142 [Vehicles and Traffic] Article IV [Stopping, Standing, and Parking] Section 142-37 [Special Purpose Parking Zones].

The Township's Code Chapter 142 (Vehicles and Traffic) Article IV (Stopping, Standing, and Parking) Section 142-37 (Special Purpose Parking Zones) shall be amended to remove one special purpose parking zone for 337 W. Maple Avenue and retain two special purpose parking zones for 338 W. Maple Avenue and 450 Railroad Avenue as follows:

Street	Side/Location	Authorized Purpose or Vehicle
338 W. Maple Avenue	South side of the street directly in front of 338 W. Maple Avenue	Parking for handicapped persons or disabled veterans
450 Railroad Avenue	North side of the street directly in front of 450 Railroad Avenue	Parking for handicapped persons or disabled veterans
337 W. Maple Avenue	South side of the street in front of 336 W. Maple Avenue	Parking for handicapped persons or disabled veterans

SECTION 2. Repeal and Ratification.

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. Severability.


Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.

SECTION 4. Effective Date.

This Ordinance shall become effective 5 days after enactment.
