AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF WHITPAIN AT PART II [GENERAL LEGISLATION] AMENDING CHAPTER 142 [VEHICLES AND TRAFFIC], ARTICLE IV [STOPPING, STANDING AND PARKING], SECTION 142-37 [SPECIAL PURPOSE PARKING ZONES] TO ESTABLISH A NEW SPECIAL PURPOSE PARKING ZONE LOCATED AT 342 MAPLE AVENUE

---

**WHEREAS**, The Board of Supervisors of Whitpain Township is duly empowered by the Second Class Township Code, 53 P.S. § 65101, *et seq.*, to enact certain regulations relating to the public health, safety, and welfare of the residents of Whitpain Township;

**WHEREAS**, The Second Class Township Code authorizes the Board of Supervisors to make, amend and adopt amendments to the Whitpain Code of Ordinances, as amended, that are consistent with the Constitution and laws of the Commonwealth that it deems necessary for the proper management and control of the Township and the best interests of its residents; and

**WHEREAS**, The Board of Supervisors of Whitpain Township have determined that Chapter 142 [Vehicles and Traffic], Article IV [Stopping, Standing and Parking], Section 142-37 [Special Purpose Parking Zones] should be amended for the orderly administration of the laws of Whitpain Township.

**NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED** by the Whitpain Township Board of Supervisors that the Township's Code is amended as follows:

**SECTION 1.**            **Amending Chapter 142-37 to Establish a New Special Purpose Parking Space Located at 342 Maple Avenue.**

The Code of the Township of Whitpain, Part II [General Legislation], Chapter 142 [Vehicles and Traffic], Article IV [Stopping, Standing and Parking], Section 142-37 [Special Purpose Parking Zones] is hereby restated and amended to add the underlined language (example) as follows:

**§ 142-37.      Special purpose parking zones.**

- A.      The following are established as special purpose parking zones, and it shall be unlawful for any person to park a vehicle or to allow it to remain parked in any such zone except as specifically provided for that zone:

Street	Side	Location	Authorized Purpose or Vehicle
<u>Maple Avenue</u>	<u>South</u>	<u>Directly in front of 342 Maple Avenue</u>	<u>Parking for handicapped persons or disabled veterans</u>

**SECTION 2. Repeal and Ratification.**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

**SECTION 3. Severability.**

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and effect, and for this reason the provisions of this Ordinance shall be severable.


**SECTION 4. Effective Date.**

This Ordinance shall become effective immediately.


